## Conditions of Agreement

Please read and initial by each item:

- \_\_\_\_\_ 1. Asheville VegFest reserves the right to accept or decline any applications at its discretion. First preference to food and beverage vendors.
- \_\_\_\_\_ 2. Each vendor must submit an individual application and payment. Spaces may NOT be combined under any circumstance.
- \_\_\_\_\_ 3. Setup begins at 8am on Sunday, September 2, 2018. Vendors must be ready for operation by 10am.
- \_\_\_\_\_ 4. All merchandise sold or given away **must be vegan (see below for definition)**, not tested on animals, and should be as environmentally-friendly as possible. If palm oil is used as an ingredient, it must be certified as sustainable.
- \_\_\_\_\_ 5. Vendors must staff their booths during the entire event from 10pm to 6pm. Breakdown is at 6pm.
- \_\_\_\_\_ 6. Vendors are responsible for setup and breakdown of their booth. Each vendor will provide their own tent (10 ft. x 10 ft. maximum). Tents must be weighed down on each corner.
- \_\_\_\_\_ 7. Vendors must have signage clearly identifying the name of the vendor. Signage can be used in booth space only. Food vendors must have signage clearly listing food offerings and prices.
- \_\_\_\_\_ 8. Vendors will be responsible for cleaning up their booth space completely. This includes all trash, boxes, recyclables, etc. If any items are left behind or trash is left around the booth space, vendor will be charged a clean-up fee of \$50.
- \_\_\_\_\_ 9. Vendors shall exhibit, sell, or give away only merchandise, literature, and services specified in Application.
- \_\_\_\_\_ 10. Vendors are expected to be environmentally responsible by minimizing waste, using recycled and compostable items when possible. Recycling stations will be set up throughout the festival area. **No Glass or Styrofoam allowed.**
- \_\_\_\_\_ 11. Should any contingency interrupt or prevent the holding of Asheville VegFest, including but not limited to inclement weather, or any other unforeseen action, event coordinators, The Asheville Vegan Society or Asheville VegFest shall in no way be liable to vendors. Should any contingency prohibit the event from taking place on September 3<sup>rd</sup> 2017, event coordinators will make their best effort to reschedule the event on a weekend day as near to the original date as possible.
- \_\_\_\_\_ 12. Vendors agree to make no claim for any reason against event coordinators or The City of Asheville for loss, theft, damage, or destruction of goods, nor for injury to themselves, employees, volunteers, or visitors incurred at the event.

**For Food Vendors Only:**

- \_\_\_\_\_ 1. All food vendors must comply with the Buncombe County Health Center Temporary Food Establishment regulations: [www.ashevilleenc.gov](http://www.ashevilleenc.gov) (then city documents)
- \_\_\_\_\_ 2. Some food vendors are required to complete the **Buncombe County Health Center Temporary Food Establishment Application**: [www.ashevilleenc.gov](http://www.ashevilleenc.gov) (then city documents) Food trucks bringing a tent instead; vendors preparing/cooking food on-site, food trucks not already permitted, etc. will need this permit. Call 828-250-5016 to confirm yes or no.
- \_\_\_\_\_ 3. All approved food/beverage vendors must submit a copy of their Temporary Food Vending Permit to Asheville VegFest within 7 days of the event.
- \_\_\_\_\_ 4. All food vendors must be set up and be ready for inspection by the Buncombe County Health Department by 10:00 am.
- \_\_\_\_\_ 5. All food sold or given away **MUST** be vegan. Vegan means no animal products: flesh, cheese, fat, broth, gelatin, egg, dairy, casein, whey, honey or other by-product. All produce must be organic and locally grown. Prepared foods shall be organic and as locally grown if at all possible. If palm oil is an ingredient used, it must be certified sustainable.

The NC Department of Revenue is now requiring all vendors who SELL a product at the Festival to have a North Carolina Sales & Use Tax ID Number or "Certificate of Registration" number. Vendors are responsible for collecting and reporting their own tax. If vendor has an existing Sales & Use Tax ID Number, a Certificate of Registration Number is not required. The application (Form NC-BR) can be completed electronically or by mail. The application is free. If you apply online, you will receive your Certificate of Registration number as soon as you complete the application. If you use snail mail, within 10 days. For more information and the form, go to [www.dornc.com/electronic/registration/index.html](http://www.dornc.com/electronic/registration/index.html). A copy of the Tax ID Number or Certificate of Registration Number is required when submitting the vendor application. Again, this is a State of North Carolina Department of Revenue law that Asheville VegFest must now enforce. Thank you.
